We have a long cherished desire for constituting a Trust in the best interest of social, culture, educational and economic development of the community especially for the Backward communities like Muslims.

Now, We the persons named below fully knowing what we are doing here, open, establish and declare this trust today the 23rd day of July 1998 subject to the terms and conditions that are shown hereunder.

**1. Name of the Trust:**

This Trust is called **NOORUL ISLAM TRUST** and its nomenclature shall be carried out in all the activities of the Trust.

**2. Board of Trustees.**

We hereby and constitute the following persons as the Trustees of this Trust (hereinafter referred to as the Board of Trustees or Board)

### 3. Office of the Trust

The Principal office of the Trust shall be at Udumbannoor, but sub offices may be opened at such other places as may be decided by the trust.

### 4. Purpose of the Trust:

- a) To establish and conduct educational institutions like Arabic Colleges, Arts and Science Colleges, Training Colleges, Medical and Engineering Colleges, schools, Hostels, Orphanages, etc. for the welfare of the community especially for the Muslims.
- b) To help, assist or otherwise support and accelerate, facilitate and propogate the educations among the members of the Muslims and other backward communities in the State.
- c) To provide scholarships, prizes, books, fees and such other financial assistances to the deserving students of the community and to help them in their studies and other educational carriers.
- d) To establish and create funds to help for the marriages of the orphans and poor girls and to extend medical aids to the poor and down trodden.
- e) To construct Home steads and to donate them to the deserving poor.
- f) To establish companies and Industries to mitigate the rigor of unemployment.
- g) To do all such charitable services as the trust may consider incidental and conducive to the attainment of any of the objects of the Trust.

5. Duration of the Board:

The Board of trustees is a permanent board and the Board is empowered and authorized to enlarge its strength by nominating members from outside as it feel necessary.

6. The office bearers of the Board:

There shall be a Chairman, Vice Chairman, General Secretary, Joint Secretary and Treasurer as office bearers in the Board. K.M.Moosa, Trustee No.1, P.M. Rajaena, Trustee No.2, K.P.Shivas, Trustee No.3, N.M. Nabeesa, Trustee No.4, and P.U. Shireena, Trustee No.5 are hereby appointed as Chairman, Vice Chairman, General Secretary, Joint Secretary, Treasurer respectively of the Board as permanent and if any vacancies arises by death, resignation, dismissal or any other shall be duly filled up by nominating members from outside.

7. Functions of the Office bearers:

1. Chairman:

The chairman will preside over all the meetings of the Board. The Chairman shall have the power to supervise the functioning of the Board and give necessary directions for the proper administration of the Board and take necessary actions if found necessary. He has the power to finish or cancel any decisions taken by the Board.

2. Vice Chairman:

The Vice Chairman shall discharge duties and exercise power of the Chairman in his absence.

3. General Secretary:

The General Secretary shall be the Principal Executive Officer (the Board shall take appropriate steps to carry out its decisions). He shall convince all the meetings of the Board in consultaion with the Chairman. He shall maintain a record of the minutes and shall be the custodian of the all the records of the Trust. He shall represent the Board in all actions, civil, criminal or revenue registration and in all offices of the Government (Central, State, Local Bodies) and foreign affairs in connection with the Chairman.

4. Joint Secretary:

The joint secretary shall assist the General Secretary in discharge of his duties. In the absence of the General Secretary, the Joint Secretary shall act as General Secretary.

5. Treasurer:


The Treasurer shall keep the funds of the Trust and maintain accounts of the Trust. He shall pay or spend amounts only by the direction of the Chairman both in writing or non-else.

8. Powers of the Board:

a) The Board, if it feels necessary shall appoint the employees for the proper functioning of the Trust and shall have power to decide all matters relating to such appointments.

- b) The Board shall approve a budget for the ensuing financial year categorizing the heads of income and expenditure. The board is at liberty to spend the unspent amount of one category to the other according to the importance and circumstances. The financial year will be April to March.
  - c) The Board shall have power to accept the Trusteeship management of any other Trust endowments and such endowments shall be administered under the provisions of the Trust.
  - d) The Board shall have power to acquire, accept or receive all endowments, gifts, grants, donations and any other contributions or any sort of movable or immovable property made to this Trust by individuals, groups, organisations, or other Trusts asset and political parties and such receipts shall be considered as part of this Trust properties.
  - e) The Board shall have power to purchase landed properties and construct building thereon. The board shall have power to pawn, pledge or mortgage the Trust properties to borrow and raise funds and loans for the purposes of the Trust and no such pawn, pledge or mortgage or sale shall be valid unless made after the decision of the Board by 75% of its existing strength.
  - f) The Board shall deposit funds of the trust in such Banks as is decided by the Board in the name of the Trust and unless and until otherwise decided by the Board. The Chairman, General Secretary and the Treasurer will jointly negotiate and operate the Bank accounts by issuing jointly signed cheques or bills etc. An amount exceeding Rs.1000/- (Rupees One Thousand only) will be deposited in the Bank.

#### 9. Notice of Sitting:

- a) The Board shall sit in session at least once in three months and members are eligible for sitting fees and traveling allowances etc. in such quantum and manner as and then decided by the Board. The General Secretary shall submit before the Board in every meeting a working report of the Trust as on the day.
- b) The General Secretary shall give minimum three days notice to the Trustees of the Board for its ordinary sitting, but the notice period can be even reduced to 24 (twenty four) hours in case of emergency.

#### 10. Quorum and Majority.

The Quorum of the Board shall be 2/3 of its strength and all the decisions of the Board shall be in writing and by the majority of the members present.

#### 11. Dismissal.

Any Trustee or Trustees whose act or any behavior found detrimental to the interests of the Trust may be dismissed by the Board by a resolution approved by the majority of 75% of the total strength of the Board.

#### 12. Enlargement of the Board:

According to the circumstances and necessity occurring as felt by the Board, the Board is empowered to enlarge its strength by nominating members from outside.



## 13. Act applicable.

This Trust is to be governed by the provisions of the INDIAN TRUST ACT (ACT 11 of 1882).

## 14. Irrevocability.

This Trust is an irrevocable Trust and neither we nor our descendants have any right or authority to revoke it.

## 15. Regulations.

By a majority of 75% of the Trustees the Board shall have power to frame regulations helpful and ameliorative to the conduct and running of the Trust. But any regulations so framed shall in no case be derogate or circumventing the directions of this Deed.


## 16. Valuation:


The Trust is valued at Rs.700/- (rupees seven hundred only). It is collected from the members of the Trust equally.


